

KONTEKST:

Potrebno utvrditi pitanje silovanja žena i dece na istoku DR Konga, u cilju analize i donošenja odluke u konkretnom slučaju, a povodom zahteva za azil lica poreklom iz DR Konga, prema izjavi iznetoj na zahtevu za azil i usmenoj raspravi;

PITANJE: Silovanje žena i dece na istoku DR Konga

ODGOVOR:

Silovanja su česta pojava širom DR Konga, ali su učestalija na istoku zemlje.^{1 2 3} Istok DR Konga se smatra za najnesigurnije mesto na svetu za žene.⁴ Iako su vlasti u DR Kongu najavile državnu politiku nulte tolerancije prema seksualnom nasilju, ona nije sprovedena.⁵ Kažnjavanje za seksualne zločine i dalje ostaje retka pojava u DR Kongu.^{6 7}

Izbijanjem novih nemira tokom 2012.godine i razmeštanjem oružanih grupa na istoku DR Konga došlo je do povećanja seksualnog nasilja na toj teritoriji.^{8 9 10}

Silovanja i seksualno nasilje koriste sve strane učesnice u konfliktu kao metod osvete protivničkim grupama, i metod zastrašivanja lokalnog stanovništva i obezbeđivanja pokornosti.^{11 12 13}

Za brojna silovanja odgovorni su i pripadnici vojske DR Konga.^{14 15} Prema nekim izveštajima samo u periodu od 15. novembra do 30. novembra. 2012.godine u oblasti oko

grada Minove u provinciji Južni Kivu, zabeleženo je oko 126 slučajeva silovanja, od čega su 24 žrtve bile maloletne devojčice.¹⁶ ¹⁷ Za većinu ovih slučajeva navodno su odgovorni pripadnici vojske DR Konga, koji su zločine počinili pri povlačenju iz borbi oko grada Gome.¹⁸ ¹⁹ Povodom ovog nasilja vojska DR Konga je pokrenula istragu protiv dva pripadnika.²⁰ ²¹

Mai –Mai milicije spadaju među grupe koje koriste devojčice kao robe i seksualno ih eksploatišu.²² Osim žena i devojčica, poslednjih godina u porastu je i broj silovanih dečaka.²³

Interno raseljene žene i deca su u posebnom riziku od zloupotrebe, uključujući i rizik od silovanja.²⁴ ²⁵ ²⁶ Posebno su ugrožena interno raseljena deca jer se veliki broj njih nalazi bez roditelja ili staratelja.²⁷

U kampu za interno raseljena lica Muganga III, koji se nalazi zapadno od grada Gome, u noći između 1. i 2.decembra 2012. upali su naoružani ljudi i silovali najmanje 12 žena.²⁸ ²⁹ ³⁰ Među njima su bile i tri devojčice.³¹

Uobičajna je praksa da žrtve silovanja ne govore o nasilju koje su pretrpele, najviše zbog „očuvanja porodične časti“.³² Žrtve seksualnog i rodno zasnovanog nasilja trpe veliku stigmu i diskriminaciju od strane društva.^{33 34} Neke od porodica prisiljavaju žrtvu da se uda za svog silovatelja.³⁵

Takođe supružničko silovanje je uobičajna pojava u DR Kongu, samo se o njoj manje raspravlja u javnosti, jer se to smatra kao unutrašnje porodično pitanje.³⁶

KOMENTAR/ZAKLJUČAK:

Silovanje žena i dece široko rasprostranjeno posebno na istoku DR Konga. Odgovornost za silovanja se pripisuju svim učesnicima u sukobu, i pobunjeničkim grupama, tako i vojsci DR Konga. U posebnom riziku od seksualnog nasilja nalaze se interno raseljena lica. Usled ovakve situacije, bezbednost, pa i životi žena i devojčica na istoku DR Konga su veoma ugroženi.
