

IMPORTANT INFORMATION FOR REFUGEES COMING FROM UKRAINE TO SERBIA

ENTRY AND STAY IN SERBIA FOR UKRAINIAN CITIZENS

- If you are a citizen of Ukraine, you can enter Serbia with your passport through any border crossing including airports.
- If you are a citizen of Ukraine, you are allowed a 90-day stay in Serbia without a visa.

Registration of stay and asylum seeking procedure in Serbia

- If you are a citizen of Ukraine, you are entitled to a right to claim asylum in Serbia, which you can redeem on course of your legal stay in Serbia (i.e. in 90 days from the date of your entry to Serbia).
- During the asylum procedure you have right to accommodation, to basic living conditions, to health care, to elementary and high school education, to freedom of movement, to free legal aid, to identification documents, to access labour market (9 months after the date of asylum claim), to obtain financial aid in case of stay at a private address.
- If there is a way that you can manage accommodation on your own, you are in no need to hurry in seeking asylum, until you are fully aware of the situation in Ukraine and until you don't make your final plans for the future.

- In case you are staying in private accommodation (with friends, family, in a hotel, or elsewhere) you have to report your stay to the local police in the period of a few days after your arrival to Serbia. For free legal aid feel free to contact our Centre, (our information can be found at the bottom of the leaflet).



REFUGEE ACCOMMODATION

- If there is no possibility for you to arrange accommodation on your own upon entering Serbia, feel free to contact our centre, (our information can be found at the bottom of the leaflet) or to contact Serbian Commissariat for Refugees and Migration, in order to get accommodation in one of the state camps.
- On course of your stay in the state accommodation camps you will have food and other basic living conditions, healthcare, humanitarian aid (shoes, clothes, etc.), education for your children, etc.



YOUR RIGHTS WHILST STAYING IN SERBIA WITHOUT SEEKING ASYLUM

- On course of your legal stay in Serbia, without seeking asylum, in private accommodation or in the state reception camps, you will be granted healthcare, elementary and high school education, humanitarian and other help, all according to the Serbian Refugees and Migration Commissariat's capacities.
